The method (s) used by the institution to determine which students received Emergency Financial Aid Grants and or Tuition assistance included abiding by the directives provided for each disbursement of grants to Auburn Career Center.

- HEERF I was disbursed equally to all students who were Title IV students as directed.
- HEERF II was also disbursed equally to all students enrolled at that time.

Auburn Career Center then used money from the Institutional portion of both HEERF I and HEERF II for students who applied for Tuition assistance and/or Direct Grants. In HEERF I, for example, Auburn distributed money to all of the students who were not Title IV so that every student enrolled received some relief.
