

2022-2023 REGISTRATION REQUIREMENTS

All full-time industrial trade programs (HVAC*, Welding*, Machining/CNC) require the following for registration:

- Application and fee
- Enrollment Agreement
- FERPA Form
- High school diploma, transcripts, or GED
- Financial aid completed, if applicable

Part-time programs do not require high school diploma, transcripts, or GED

The following programs require the items listed before registration is considered complete.

<p>Emergency Medical Technician (EMT)* and Emergency Services Telecommunicator (EST)</p> <ul style="list-style-type: none"> • Pass pre-entrance test for EMT or WorkKeys for EST • Application and fee (waived if an Auburn student) • Enrollment Agreement • FERPA form • References • Copy of driver’s license • Official transcript, high school diploma, or GED (high school seniors excluded) • BCI background check (will accept a receipt for registration only) • Drug Screen (waived if already an Auburn Fire student) • <i>Financial Aid Completed for Telecommunicator</i> 	<p>Firefighter 1 & 2</p> <ul style="list-style-type: none"> • Pass pre-entrance test • Application and fee (waived if an Auburn student) • Enrollment Agreement • FERPA form • References • Copy of driver’s license • Official transcript, high school diploma, or GED (high school seniors excluded) • Proof of EMS Card <i>or</i> proof/copy of current CPR & First Aid card or is a current EMT student • BCI background check (will accept a receipt for registration only) • Drug Screen
